Adarsh College is situated in a prime locality near the Badlapur railway station on 13 acres of the land. The College has huge campus with lush green surrounding. The College administration has renovated college building and upgraded its infrastructure to further enhance quality of our services. It has a plan of extension of its building with addition of two wings separately for administration, library and other support services.

Students' Support Facilities

I. Library: 'Ceaseless Source of Knowledge'

1. The college has a spacious Library with a well lit and well ventilated reading hall.
2. The college library is the hub of learning with a collection of about 31441 books including 16207 general reference, 97 Encyclopedias, 53 national and international journals and magazines, 547 bound volumes of old periodicals and 318 CD ROMs and collection of 32 maps. We also subscribe e-resources under N-LIST Program.
3. The student-friendly staff provides guidance and conducts numerous programs. The college arranges Orientation for newly admitted students. The college arranges Book exhibitions regularly.
4. Special reference section on career guidance is arranged for the benefit of the students.

6. The college has a separate E-library section, There is a display of QR code panel for easy accessibility of the available resources.
7. The college management provides Book Bank Scheme to the students of Self Finance Courses. It also provides 'Single Parents' Book Bank Scheme' & disability Book Bank Scheme.

Library Rules:

Timing:

1. The library facility can be availed on all working days from 8.00 am to 4.00 pm except Sundays and public holidays.
2. Home reading section operates as per timing notified.

Reading Room:

1. Separate Reading Rooms for Girls and Boys
2. Reading Rooms remains open for students from 8.00am to 4.00pm.
3. Students must possess his/her valid identity card and reader ticket while entering library reading room.
4. Students who enter the reading room must sign Students Attendance Register.
5. Students must observe complete silence in reading room.
6. Text books, reference books, periodicals and newspapers are issued only against valid reader's ticket.

Home Issuing:

1. Students can borrow text books for a week only against their valid home reading cards.
2. The books are issued for home reading section according to following time table.

3. Students must handle books issued to them with proper care.
4. If the books are not returned on the due date, a student will be charged with an overdue charge of Rs. 3/- per book per day.
5. In case of loss of books or if it gets damaged, the concerned student shall replace the book or shall pay the cost of the book as directed by college administration.
6. Students who repeatedly fail to return book on due date will lose the privilege of membership.

Book-Bank:

1. Students belonging to Backward Class are entitled to get books on loan basis for the academic year under Book Bank Scheme. There are 3317 books under this scheme.
2. The college provides special book bank scheme on its own initiatives for single parent students.
3. The students who wish to avail this facility should submit a duly prescribed form to the library authority.

Admission Procedure:

From academic year 2017-2018 the college has started online admission. The student who wants to seek admission must fill up the online application form and download the same for print. The hard copy should be submitted to the college office within 24 hrs. This is in addition to the online registration on University of Mumbai portal.

Eligibility for Admission to Three Year Degree Program:

Admission to F.Y.B.A./B.Com

A candidate to be eligible for admission to the Three Year Integrated Program leading to the Degree of Bachelor of Arts/ Commerce must have passed the Higher Secondary School Certificate (S.Y.J.C.) Examination conducted by the Maharashtra State Board of Secondary and Higher Secondary Education, Mumbai or an examination recognized as equivalent with subjects, as may be specified by the University in Arts, Science or Commerce streams.

Student passing examination equivalent to S.Y.J.C. of the Higher Secondary Board, other than Mumbai/Intermediate (Arts/Science/Commerce) from other state and immigrating from other Universities / Boards seeking admission to the F.Y. of the Three Year integrated Degree Program will be admitted only on production of a 'Provisional Eligibility Certificate' issued by the University of Mumbai. Such students shall also submit a Migration Certificate, Statement of Marks and Passing Certificate in original along with true copies within two months from the date of admission, failing which their admission is liable to be cancelled.

THREE YEAR B.A. DEGREE PROGRAM

Program composition at B.A.

There are Core/major courses, non major/non-core courses, non credit (add-on) optional component, compulsory component / electives etc. The total credits cover the core, elective, field work or extension activities, soft skills etc. Each core course has 3 credits whereas Foundation course, compulsory language and communication skills courses and general applied component course have 2 credits each. There is a project component (2 in number) for 2 credits in the last year Semesters.

❖ **EXAMINATION PATTERN :-**

University of Mumbai introduced Choice Based Credit System for First Year of all its undergraduate programs viz. B.A., B. Com. from the year 2016-17. The salient features of this system are as follows.

- In this system, a faculty is called program, subject paper is called course and a student is called a learner.
- All the regular undergraduate programs of University of Mumbai are semester based i.e. First Year (Sem. I & II), Second Year (Sem. III & IV) and Third Year (Sem. V & VI).
- A learner (student) will undergo semester-wise two examinations per year. Semester I, III and V examinations will commence in the month of October/November and semester II, IV and VI in the month of March/April.
- Each semester end examination carries 100% weightage in each course except Foundation Course where 75% weightage for external examination and 25% weightage for internal assessment in the form of project work as assigned by the teacher.
- A learner must score 40% of marks in internal and semester end examination of each course separately. e.g. To pass in each course, a learner must secure minimum 40 marks out of 100 in semester end examination separately.
- A learner who fails to appear at semester end examination on Medical ground or for representing the College/University in Sports, Cultural Activities, N.C.C., N.S.S. conducted by recognized bodies/ competent authorities or for any other reason which is considered valid under exceptional circumstance & to the satisfaction of the Principal, is eligible to appear for the additional examination, subject to University guidelines.
- The details of Examination pattern is explained in the Welcome Address and subsequently by the subject teacher in the classes.
- The pattern of examination is subject to the changes introduced by the University of Mumbai from time to time.
- For regular and additional examinations, if eligible, a learner has to pay examination fees separately.
- A learner who passes clearly or passes with not more than two ATKTs in the courses of each semester is eligible to take admission for the next year.

1. A learner will be given grade points for each course according to the following table.

- The marks will be given for all examinations and they will be converted into grade (quality) points. The semester-end, final grade sheets and transcripts will have only credits, grades, grade points, SGPA and CGPA.
- To complete any program (B.A., B.Com. etc.) successfully, a learner has to clear all its semester-wise courses with minimum of 40% marks separately in internal assessment and semester end examination.

❖ **ATKT for Program of Arts and Commerce is read as under:-**

- a. A learner shall be Allowed To Keep Term for Semester II irrespective of number of heads of failure in the Semester I.
- b. A learner shall be allowed to keep term for Semester III if he/she passes each of Semester I and Semester II

OR

Learner who fails in not more than four courses of Semester I and Semester II taken together with not more than two courses each in semester I and II.

- c. A learner shall be allowed to keep term for Semester IV irrespective of number of heads of failure in Semester III.
- d. A learner shall be allowed to keep term for Semester V if he/she passes Semester I, Semester II, Semester III and Semester IV

OR

A learner shall pass Semester I and Semester II and fails in not more than four courses of Semester III and Semester IV taken together with not more than two courses each in sem. III and Sem. IV.

- e. A learner shall be allowed to keep term for Semester VI irrespective of number of heads of failure in the Semester V.
- f. The result of Semester VI shall be kept in abeyance until the learner passes each of Semester I, Semester II, Semester III, Semester IV and Semester V.

❖ **Verification of Marks / Photocopy of Answer-books:**

A learner who wishes to apply for Verification of marks/photocopy of Answer books is required to submit the prescribed application form available in the college office on payment of Rs.10/- per form and submit the filled form to the cashier in the college within 7 days of the date of declaration of results.

A. Verification of Marks:

Application along with –

- i) Fees Rs.50/- per course & ii) Attach photocopy of Mark-sheet.

B. Photo copy of Answer books:

(Ref. University Circular No. Exam/VCD/College (Rev./Ver.)/1603/of 2005)

- Application along with documents:
 - i. Fees Rs.100/- per course (Non-refundable) – Rs. 50/- (Reserved Category Students)
 - ii. Copy of Question paper.
 - iii. Photocopy of Caste Certificate for reserved category students.

The application (in the form prescribed by the respective college if any) for obtaining photocopy of answer books signed by the applicant, examinee/s, only shall be submitted to the respective College within 7 days from the date of declaration of result for the examination held.

The Photo / Zerox copy/ies shall be provided by the college/institution to the applicant examinee/s in person only and under no circumstances to any person/s examinee/s agent/s of application.

The applicant examinee shall be the sole custodian of photo/Zerox copy and under no circumstances they shall be transferred to any third person or for any other purpose/s.

If the applicant so desires, he / she can use it only for the purpose of getting the redressal of the grievances through the redressal mechanism provided by the college/institution under these rules.

Any deviation from this procedure by the applicant shall be construed as an unfair act on part of the examinee and shall make him/her liable for appropriate punishment by the college.

C. Re Valuation of Answer Books:

The application form (prescribed by the respective college if any) for redressal of grievances regarding valuation of answer books can be obtained from college. The examinee shall have to mention clearly in the application form, the reasons for his/her grievances and specify clearly the question wise his/her points of objection to the valuation done with proper justification.

The prescribed application duly filled in shall be submitted with a fee of Rs. 500/- per course to the respective College/institution and 50% concession for SC & ST candidates.

The application form (as prescribed by the respective college if any) shall have to be signed by the applicant examinee himself/herself and shall be submitted to the college within 7 days from the date of the receipt of the concerned photo/Zerox copies. Incomplete application form/s in any respect shall be rejected without assigning any reason and the fees paid along with the application form shall not be refunded.

❖ **Exemption :**

A unsuccessful learner who obtains the minimum percentage of marks prescribed for passing in the subject may, at his/her option, be exempted from appearing in that subject/practical at his/her subsequent appearance and will be declared to have passed the whole examination on his/her passing in the remaining in which he/she has failed.

❖ **Ex-Students :**

Candidates who have been declared 'fail' at the examination or who have been allowed to keep terms for the higher class shall appear as Ex-student for the annual examination held by their respective colleges, as per university guidelines.

❖ **UNIVERSITY ORDINANCES RELATED TO EXAMINATION**

(Ref. University of Mumbai Circular of 2011-12)

- **ORDINANCE O.5042 - A: - Grace Marks passing in each course / head of passing (Theory / Practical / Oral / Sessional / TW / External / Semester End Exam / Internal Assessment)**

The examinee shall be given the benefit of grace marks only for passing in each course / head of passing (Theory / Practical / Oral) in External / Semester End Examination or Internal Examination Assessment. Provided that the benefit of such gracing marks given in different courses / head of passing shall not exceed 1% of the aggregate marks in that examination.

Provided further that the benefit of gracing of marks under this Ordinance, shall be applicable only if the candidate passes the entire examination of semester / year.

- **ORDINANCE O.5043-A: - Grace Marks for getting Higher Class / Grade**

A candidate / learners who passes in all the subjects / courses and heads of passing in the examination without the benefit of either gracing or condonation rules and whose total number of marks falls short for securing Second Class / Higher Second Class / First Class or next Higher Grade by marks not more 1% of the aggregate marks of that examination or up to 10 marks, whichever is less, shall be given the required marks to get the next higher or grade as the case may be.

Provided that benefits of above mentioned grace marks shall not be given, if the candidate fails to secure necessary passing marks in the aggregate course / head of passing also, if prescribed, in the examination concerned.

Provided further that benefits of above mentioned grace marks shall be given to the candidate for such examination/s only for which provision of award of Class / Grade has been prescribed.

- **ORDINANCE O.5044-A: Grace Marks for getting distinction / Grade ‘O’ in the subject / course only.**

A candidate / learner who passes in all the Courses or Subjects / Heads of passing in the examination without benefit of either gracing or condonation rules and whose total number of marks in the courses / subject/s falls short by not more than three marks for getting Grade ‘O’ / distinction in the courses / subject/s respected shall be given necessary grace marks up to three (03) in maximum two subjects, courses subjects to maximum 1% of the total marks of that Head of Passing whichever is more, in a given examination.

Provided that benefits of above mentioned grace marks shall be given to the candidate only for such examination/s for which provision for distinction in a course / subject has been prescribed.

- **ORDINANCE O.5045-A: Condonation**

If a candidate / learners fails in only one course / head of passing, having passed in all other courses/heads of passing, his/her deficiency of marks in such head of passing may be condoned by not more that 1% of the aggregate marks of the examination or 10% of the total number of marks of that course / head of passing in which he / she is failing, whichever is less. However condonation, whether in one head of passing or aggregate head of passing be restricted to maximum up to 10 marks only.

Condonation of deficiency of marks be shown in the Grade Card / Statement of Marks in the form of asterisk and Ordinance number.

- **ORDINANCE O.5048-A: Amendments of Results**

Due to errors

In any case where it is found that the result of an examination has been affected by errors, the Controller of Examinations shall have power to amend such result in such manner as shall be in accordance with the true position and to make such declaration as is necessary, with the necessary approval of Vice Chancellor / Pro Vice Chancellor, provided the errors are reported / detected within 6 months from the date declaration of results. Errors detected thereafter shall be placed before the Board of Examinations.

Error Means:

- i) Error in computer / data entry, printing or programming and the like.
- ii) Clerical error, manual or machine, in totaling or entering of marks on ledger / register.
- iii) Error due to negligence or oversight of examiner or any other person connected with evaluation, moderation and result preparation.

A. Due to fraud, malpractices etc.

In any case where the result of an examination has been ascertained and published and it is found that such result has been affected by any malpractices, fraud or any other improper conduct whereby an examinee has benefited and that such examinee, has in the opinion of the Board of Examination been party or privy to or connived at such malpractice, fraud or improper conduct, the Board of Examination shall have power at any time notwithstanding the issue of the Certificate or the award of a Prize or Scholarship, to amend the result of such examinee and to make such declaration as the Board of Examination considers necessary in that behalf.

Note: a)The Ordinances O.5049, O.5050 will be as per the existing ordinances. However, the term “Student” be read as “Learners”

b)The Number of the Ordinances will be same. However, it is followed by alphabet ‘A’ only.

- **ORDINANCE O. 5050: Unfair Means at the Examination:**
- 'Unfair means relating to examination' means and includes directly or indirectly committing or attempting to commit or threatening to commit any act or coercion, undue influence or fraud of malpractice with a view to obtaining wrongful gain to him or to any other person or causing wrongful loss to other person/s.
- 'Unfair means material' means and includes any material whatsoever, related to the subject of the examination, printed, typed handwritten or otherwise on the person or on clothes, or body of the student (examinee) or on wood or other material, in any manner or in the form of chart, diagram, map or drawing or electronic aid etc. which is not allowed in the examination hall.
- 'Possession of unfair means material by a student' means having any unauthorised material on his/her person or desk or chair or table or at any place within his/her reach, in the examination centre and its environs or premises at any time from the commencement of the examination till its conclusion.
- ❖ The Broad Categories of Unfair Means Resorted to by Students at the University / College / Institution Examinations and the Quantum of Punishments for each Category thereof.

STUDENT SUPPORT SYSTEM

❖ **Students' Welfare Fund**

The college has a Students' Welfare Fund from which deserving and needy students of the degree college are given financial assistance to meet their tuition/examination fees, cost of books, S.T. Pass, medical charges etc. Students should apply for assistance in response to the notice issued in this regard voluntarily. Every student of the degree college has to contribute Rs. 50/- (Rupees Fifty Only) as yearly contribution towards the Students' Welfare Fund.

❖ **Book- Bank Scheme for Backward Class Students**

According to the guidelines of Department of Students' Welfare of University of Mumbai, the college has 'University of Mumbai- Book Bank Scheme' for Backward Class Students. Books are issued for one academic year only. Students are expected to use the books with care and return them to the book bank after the examination. At present, the book bank has a collection of more than 1900 books. Books for various competitive examinations are also available in the book bank. Students are expected to follow the rules of the book bank strictly.

❖ **Scholarships and Freeships**

Government Scholarships and Freeships are available to the students of the college. Students are given necessary guidance and co-operation in securing these scholarships and freeships from concerned authorities. The scholarships and freeships are as follows:

1. Government of India scholarship to Scheduled Caste and Lower Income Group.
2. Maharashtra State Economically Backward Class Free Studentship.
3. Freeship to sons and daughters of Primary School Teachers in Maharashtra State.
4. Freeship to Scheduled Caste/ Scheduled Tribes Students.
5. National Loan Scholarship.
6. National Merit Scholarship.
7. Maharashtra State Open Merit Scholarship for students of all communities.
8. Maharashtra State Scholarship to Children of Freedom Fighters.
9. Freeship (Fee concessions) to Children of Ex-Servicemen and Physically handicapped students.
10. Any other scholarship or free ship declared by the Central/ Maharashtra Government during the course of the academic year.

❖ **Scholarship for Minority Students:**

Maharashtra Government Minority Development Department has started scholarships for Minority Students belonging to Muslim, Sikh, Bouddha, Christian, Parsee and Jain community taking admission for traditional courses i.e. Arts, Commerce and Science after H.S.C. for Graduation and Post-Graduation studies. Under the scheme annual tuition fees or Rs. 5000/- whichever is less will be given as scholarship. ❖ **Fee Reimbursement Scheme**

This Scheme is introduced by the college from 2009-10 especially for students who are financially weak and worthy of such financial help and **those students who do not get any assistance from government schemes for any reason. The students can apply under this scheme to get refund of their fees partially or fully.**

❖ **Group Insurance Scheme for Students**

A student taking admission in a college is insured under the Group Insurance Scheme for Students. If a student is insured in a particular College / Department / Institution and later if he/she takes admission in another college / institution anywhere in India the premium will be not refunded and the insurance claim of the student will be settled through the authorities where she/he has paid the premium. As per the University circular **SW/47 of 2005** dated Dec, 14/2005 an annual fees of Rs. 20/- & Rs. 40/- charged per student for UG & PG respectively.

❖ **Rules regarding Bus/Railway Concessions**

- a. Students can purchase Railway Season Tickets at concessional rates only between Badlapur railway station and the railway station nearest to their residence. Residential address given on the admission form will be taken as for this concession. It cannot be changed during the course of the academic year.
- b. Students can use S.T. bus service between Badlapur S.T. Bus Depot and the S.T. Bus stop nearest to their residence. Students will be given concession according to rules of State Transport authorities.
- c. **The native place declared on the admission form will be the basis for long journey concessions.** The native place once declared cannot be changed during the academic year/ till the completion of course.

❖ **Anti-Ragging Act**

As per the circular from Joint Director, Higher Education, Maharashtra Government (Ref. 2005/238/05), vishi-1, dated 28th July 2007), the student found guilty of Ragging already will not be given admission in college or if found guilty of Ragging even after admission in college, will be removed /debarred from the college. Every student has to submit the online undertaking for confirmation of Anti-Ragging Activities on the campus, as per UGC D.O. No. F.1-15/2009(ARC) pt-III published December, 2018.

❖ **Internal Complaints Cell**

According to the Rules of 9th December 2013, the Internal Complaints Committee to investigate into the Sexual Harassment Complaints has been constituted in the College. The college conducts workshop on Orientation about this Act of POSH.

❖ **Rules regarding Refund of Fees**

O.2859: Refund of Tuition, Development and all other fees after cancellation of admissions:
(Ref. University of Mumbai Circular No. UG/412 of 2008)

The candidates who have taken admission in under graduate courses in Govt. colleges, in Govt. aided & unaided courses conducted by affiliated colleges, and recognized institutions

may request for refund of fees after applying in writing for cancellation of their admission to the course. The refund of fees as applicable shall be made on or before 30th day after the date of cancellation and thereafter. The percentage of fee for the course shall be refunded to the candidate after deducting charges as follows:

Period and Percentage of Deduction Charges (As per University of Mumbai Circular No. UG/412 of 2008 dated 11th September 2008)

If cancellation of Admission is:

1. Prior to commencement of academic term and instruction of the course then the deduction charges will be Rs. 500/- lump sum.
2. Up to 20 days after the commencement of academic term of the course then deduction charges will be 20% of the total amount of fees.
3. From 21st day up to 50 days after commencement of the academic term of the course then deduction charges will be 30% of the total amount of fees.
4. From 51st day up to 80 days after commencement of the academic term of the course or August 31 whichever is earlier then deduction charges will be 50% of the total amount of fees.
5. From September 1st to September 30th, then the deduction charges will be 60% of the total amount of fees.
6. After September 30th, then the deduction charges will be 100% of the total amount of fees.

NOTE: The total amount considered for the refund of fees from the commencement of academic term of the courses includes the following:

1. All the fee items chargeable for one year are as per relevant University circulars for different Faculties (excluding the courses for which the total amount is fixed by other competent authorities).
2. The Fee charged towards group insurance and all fee components to be paid as University share (including Vice-Chancellor fund, University fee for sports and cultural activities, E-charges, disaster management fund, exam. fee and Enrollment fee) are non refundable if payment is made by the college prior to the date of cancellation.
3. Fee collected for Identity card and Library card, admission form and prospectus, enrollment and any other course specific fee are not refundable after commencement of the academic term.
4. All refundable deposits (Laboratory, Caution Money and Library etc) shall be fully returned at the time of cancellation.

ATTENDANCE RULES

The following shall be the minimum attendance necessary for keeping terms for B.A./B.Com. students.

Minimum 75% attendance in Each Term / Semester.

O.125: To keep a term at a college or recognized institution, an undergraduate must complete to the satisfaction of the Principal or Head of the Institution the course of study at the college or institution prescribed for such terms for the class to which such undergraduate then belongs.

CODE OF CONDUCT FOR STUDENTS

1. All the students who have taken admission in the College must possess valid Identity Card. (Identity Cards are issued by the college in the beginning of the first term). Students must carry with them their Identity Card and should produce them whenever demanded by the Teaching and Non-Teaching staff. Identity Card should be preserved carefully. The holder of the Identity Card will be held responsible for its misuse. In case of loss of Identity Card a duplicate card must be obtained by paying the prescribed charges with due procedure.
2. Students should read the notices on the Notice Boards daily.
3. Students should submit applications for scholarship / freeship etc. as also the Enrolment form (for first year degree students) on time as per the Notices put up on the Notice Board.
4. Students must maintain silence in the classes, Library, Reading Room, Office, and the corridors. When they are free, they should make use of the College Library, of the Students Common Room, and must not loiter in and around the college premises or assemble in the corridor. Loud conversation and shouting should be avoided.
5. **Dress and Hair Style should be in conformity with the standards accepted by the institution.**
6. **Absence in any one lecture in a day will lead to losing the attendance for the whole day. Minimum 75% attendance and satisfactory progress in studies are the essential requirements for students to become eligible for being sent up for Board / University / College Examinations.**
7. Admission to a particular class does not automatically guarantee admission to higher classes in future. Admission to all classes will be on the basis of performance and availability of seats.
8. Smoking, chewing tobacco and Gutkha is strictly prohibited in the college building and in the college campus.
9. Use of mobile is strictly prohibited in the Class Room. Use of mobiles with camera and tape are strictly prohibited in the campus. Individual tapes and cameras are also not allowed.
10. **The candidate should remain personally present at the time of Admission.**
