महाराष्ट्र तत्त्वज्ञान परिषद ही महाराष्ट्रातील तत्त्वज्ञानाचे प्राध्यापक, विद्यार्थी आणि तत्त्वज्ञान प्रेमी यांची परिषद आहे. तत्त्वज्ञान विषयाचे मराठीतून अध्ययन व संशोधन व्हावे, या विषयासंबंधी उत्कृष्ट साहित्य निर्मिती व्हावी, तात्विक चर्चांना व्यासपीठ उपलब्ध व्हावे, समाज परिवर्तन व सामाजिक विकासाला, उपयुक्त अशा तंत्रज्ञानाची निर्मिती व्हावी, या उद्देशाने १९८२ साली परिषदेची स्थापना करण्यात आली. परिषदेच्या स्थापनेत व जडणघडणीत महाराष्ट्रातील ज्येष्ठ विचारवंत व तत्त्वज्ञ तर्कतीर्थ लक्ष्मणशास्त्री जोशी, डॉ. सुरेंद्र शिवदास बारलिंगे, प्रा. मे. पुं. रेगे, प्रा. दि. य. देशपांडे, प्रा. शि. स. अंतरकर, प्रा. श्रीनिवास हरि दीक्षित इत्यादींचा मोलाचा वाटा आहे. ही संस्था स्थापनेपासून आपल्या उद्दिष्ट्य पूर्तीसाठी विविध उपक्रम राबवित आहे. गेली ३७ वर्षे नेमाने वार्षिक अधिवेशने आयोजित करणे हा परिषदेचा उल्लेखनीय उपक्रम आहे. सामाजिकदृष्ट्या महत्त्वाच्या विषयांवर परिषदाद्वारे घडवून आणून त्यानिमित्ताने विचारवंतांचे मौलिक विचार लोकांपर्यंत पोहोचविण्याचे संस्थेचे कार्य उल्लेखनीय आहे.
