WASTE MANAGEMENT POLICY

Introduction:

Adarsh College of Arts and Commerce has played a pivotal role in development of educational facilities in and around Badlapur area for more than 2 decades. The primary focus of the 'Waste Management Policy' of the college is to make significant contributions in the field of ecological sustainability while giving due consideration to systematic waste management and waste minimization in and around college campus.

This policy aims to guide the key stakeholders of the college viz. Student community, staff members and management in the way to oblige with their collective responsibility towards waste production, waste segregation, waste storage, handling and transportation, and waste disposal.

Aims and Objectives of Waste Management Policy:

- To create a healthy ecological environment and resource-efficient society.
- To strive for minimizing waste production and treat the produced waste systematically by implementing the 4R policy viz.
 - Reduce unnecessary usage of limited resources
 - Reuse the existing resources wherever possible
 - Recycle waste material
 - Refuse use of eco-harming material like plastic and non-biodegradable material and substitute it with eco-friendly and biodegradable resources.
- To inculcate sensitivity among staff and student community about the importance of systematic Waste Management for creating a sustainable environment. This policy document aims to act as a guiding torch on:
 - How to minimize waste production?
 - How to positively engage the internal and outside community in Waste Management activities such as waste collection, waste segregation (into wet waste, dry waste, plastic waste, electronic waste, medical waste, metal waste etc.), recycling of waste, appropriate waste disposal so as to not impact the environment negatively.

- To give proper orientation and required training to both- students and staff members regarding management of solid, liquid and electronic waste.
- The policy will help to maintain a clean, green and pristine college campus.

Waste Management Policy Guidelines:

Solid Waste Management:

- Students and staff will be instructed to use the waste bins placed at the college campus and not to litter the surrounding environment.
- Awareness will be created about waste management techniques by way of various activities, programs, seminars and lectures.
- It is proposed to organize activities like plastic waste collection drive, e-waste collection drive. The college will act as a link between the waste recycling organization and waste producers. MOUs will be entered into in this regard.
- Special Orientation sessions by experts will be conducted for students who wish to pursue entrepreneurial career in the field of waste management.
- It is proposed to establish an incinerator to dispose-off garbage.
- The college will also organize activities like best out of waste competitions.
- The college will try to reuse decorative materials in multiple events and functions.

Reducing 'Paper Waste' Policy:

- Reusing one side used papers wherever possible to curtail excessive and unnecessary paper wastage.
- Circulation of e-learning resources rather than printed notes.
- Instructing students not to take unnecessary supplements and not to leave unnecessary space in the answer-sheets during examinations. Also reducing the number of pages in the answer booklet for minor internal examinations.

Liquid Waste Management:

- There will be proper and regular maintenance of the drainage system to avoid clogging and related issues.
- It is proposed to establish a toilet waste water treatment plant. The wastewater will be recycled to water the plants and also in the toilet flush tanks.

➤ **College Level Initiatives:**

- Food in excess during special college events will not be wasted and will be supplied to the needy.
- The college will foster the use of reusable plates, glasses and cutlery during college events, functions, visits and camps rather than generate additional plastic and thermacoal waste.
- The college will try to reuse decorative materials in multiple events and functions.

➤ **Community Level Initiatives:**

- Organizing Rally, Swachata Abhiyaan, and Street-play for creating awareness in the community.
