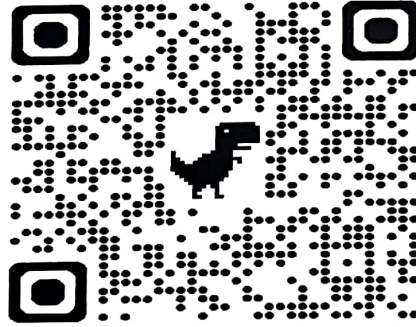

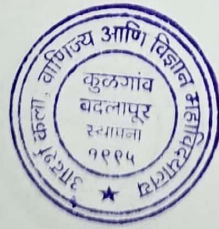

4. **Students should have their single account in bank/post office and in operating Mode.**
5. **Domicile Certificate.**
6. **HSC and SSC marksheet.**
7. **Current year fee receipt**
8. **Gap certificate** - In case of gap it is mandatory.
9. **Declaration certificate of parents/guardians** about number of children beneficiaries
10. **Fathers death certificate** – If applicable
11. **Non Crimilayer** ( For OBC, SBC, VJNT Freeship only for Self finance courses)
12. **Leaving Certificate**
13. **Ration card for identify number of children's in family.**
14. **Disability Certificate by Civil Surgeon for PH Category students.**
